SKILLS & COMPETENCIES TO BE DEVELOPED	<ul style="list-style-type: none"> • Historical Empathy and Understanding: Students develop resilience, respect, and integrity by engaging in historical inquiry, critically analysing sources, and demonstrating sensitivity to the context of historical actions and interpretations. • Social and Emotional Competencies: Collaborative learning experiences in history classrooms foster social awareness, relationship management, and responsible decision-making as students navigate different perspectives and build emotional intelligence. • Global Awareness and Critical Thinking: The history curriculum equips students with civic literacy, global awareness, and cross-cultural skills, while also developing critical thinking and communication abilities through inquiry-based learning and the evaluation of historical sources.

Confident, Self-Directed Learners: Geography students become confident individuals with a strong sense of right and wrong, adaptability, and effective communication skills. They are self-directed learners who question, reflect, and take responsibility for their own learning.</p> <p>2. Active Contributors: Students are innovative and effective team players, taking initiative and calculated risks to strive for excellence and contribute positively to their communities.</p> <p>3. Concerned Citizens: Students develop a strong sense of civic consciousness and global awareness, actively participating in the betterment of society and using tools such as maps, fieldwork, and GIS to understand and address real-world issues.</p>

This disposition helps them appreciate Singapore's multicultural society and navigate interactions with people from various walks of life. It also promotes social harmony and inclusivity.
